

TYPAR® LIMITED WARRANTY FOR COMMERCIAL APPLICATIONS

The installation of Fiberweb™ Typar® Housewrap, Typar® Metrowrap™, Typar® Peel & Stick Flashing, Typar® Flex Flashing, Typar® Flashing RA, and Typar® Construction Tape ("Typar Products") on your Commercial Building (defined below) entitles you to the protection provided by the Typar® Limited Warranty for Commercial Applications.

Limited Warranty. Fiberweb, Inc. ("Fiberweb") warrants that its Typar Products shall perform to their published specifications if installed on a Commercial Building in strict accordance with the published installation procedures, accepted industry standards and applicable building codes in a properly constructed and designed wall system. If a Typar Product installed in a Commercial Building fails to perform to published product specifications during the one (1) year period after installation, Fiberweb shall replace or pay the cost of the failed Typar Product.

Definition of Commercial Building. As used in this Limited Warranty, the term "Commercial Building" means all buildings other than detached single family or two family dwellings.

How to make a warranty claim. All claims under this Limited Warranty must be made promptly in writing to Fiberweb, Inc., 70 Old Hickory Blvd., Old Hickory, Tennessee 37138, Attention: Technical Manager. Acceptable validation of purchase date (letter of invoice from builder, building material supply company) must be included with all written claims. If Fiberweb determines that an investigation of the claim is necessary, the claimant must permit Fiberweb's Typar® representative to access and view the property specified in the claim and to take photographs and samples, as may be necessary.

Limitations. This Limited Warranty is the only warranty made by Fiberweb in respect of Typar Products installed on Commercial Buildings and is user's SOLE AND EXCLUSIVE remedy under tort, contract or statutory law. This Limited Warranty does not apply to damage due to abuse or mishandling of product(s), improper installation or damage caused primarily by someone or something other than Fiberweb's product(s).

This Limited Warranty is non-transferable.

EXCEPT AS TO THE ABOVE LIMITED WARRANTY, FIBERWEB MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AND DISCLAIMS ALL OTHER WARRANTIES INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. OTHER THAN ITS OBLIGATIONS UNDER THE LIMITED WARRANTY AS STATED ABOVE, IN NO EVENT SHALL FIBERWEB BE LIABLE TO ANY PERSON OR ENTITY FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR REVENUE, LOSS OF USE, PERSONAL INJURY OR DAMAGE TO PROPERTY CONTENTS.

This Limited Warranty applies to all Typar Products installed on Commercial Buildings purchased on or after April 1, 2007.

TYPAR® LIMITED WARRANTY FOR RESIDENTIAL APPLICATIONS

The installation of Fiberweb™ Typar® Housewrap, Typar® Metrowrap™, Typar® Peel & Stick Flashing, Typar® Flex Flashing, Typar® Flashing RA, and Typar® Construction Tape ("Typar Products") on your Residence (defined below) entitles you to the protection provided by the Typar® Limited Warranty for Residential Applications.

Limited Lifetime Warranty. Fiberweb, Inc. ("Fiberweb") warrants that each Typar Product will perform to its published specifications if installed on a Residence in strict accordance with the published installation procedures, accepted industry standards and applicable building codes in a properly constructed and designed wall system. If a Typar Product fails to perform to its published product specifications, Fiberweb shall replace or pay the cost of such failed Typar Product for the lifetime of the Residence.

Additional Typar® Weather Protection System Limited Warranty. If Typar Products are installed for the entire building envelope of a Residence (referred to as the Typar® Weather Protection System™) in accordance with Fiberweb's installation procedures, accepted industry standards and applicable building codes in a properly constructed and designed wall system, and a Typar Product fails to perform according to its published product specifications during the ten (10) year period after installation of the entire Typar® Weather Protection System, Fiberweb shall (in addition to the replacement of or payment for the cost of the Typar Products) pay construction costs (labor and materials) to correct any problem caused solely by the failure of the Typar Products to conform to such published specifications.

Definition of Residence. As used in this Limited Warranty, the term "Residence" means only detached single family or two family dwellings.

How to make a warranty claim. All claims under this Limited Warranty must be made promptly in writing to Fiberweb, Inc., 70 Old Hickory Blvd., Old Hickory, Tennessee 37138, Attention: Technical Manager. Acceptable validation of purchase date (letter of invoice from builder, building material supply company) must be included with all written claims. OTHER THAN ITS OBLIGATIONS UNDER THE LIMITED WARRANTY AS STATED ABOVE, IN NO EVENT SHALL FIBERWEB BE LIABLE TO ANY PERSON OR ENTITY FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR REVENUE, LOSS OF USE, PERSONAL INJURY OR DAMAGE TO PROPERTY CONTENTS.
